Participants would be able to work in an automotive workshop as skilled light vehicle motor mechanics responsible for inspecting, diagnosing difficult faults, and repairing faults and able to use highly technical equipment and have a sound level of understanding of vehicle and machinery systems. TRAINING AND ASSESSMENT INFORMATION






This course is delivered face-to-face in a classroom-based and simulated automotive repair workplace setting. The timetable for this course will be advised in your Offer Letter and Student Agreement.

You are required to attend classes for 20 hours per week for 60 study weeks (5 terms of 12 weeks each). You are also expected to perform approximately 2 hours of unsupervised self-study per week.

Holiday breaks are a total of 6 weeks and will be indicated in your timetable. Class sessions include a mix of theory and practical activities with a focus on creating a real-life automotive workplace.

In addition to face-to-face learning and assessment, you will also need to complete approximately 2 hours of additional, unsupervised study per week including general reading and research for assessments.

You will also need to complete assessments for this course which may include:

-  Written questions
-  Multiple choice questions
-  Reports
-  Job cards
-  Practical demonstrations







At the beginning of each unit, your trainer and assessor will outline the assessment tasks that must be completed. Your classes will be conducted in a combination of a simulated automotive repair workplace and modern classrooms, and you will be able to access Wi-Fi and a range of automotive equipment, tools, and fixtures. There are also areas for you to relax, as well as conduct additional study.

WHAT ARE THE ENTRY REQUIREMENTS?

- ✚ Must be at least 18 years of age.
- ✚ Participate in a course entry interview/pre-training review to determine suitability for the course and student needs.
- ✚ Have an IELTS* score of 5.5 (test results must be no more than 2 years old). English language competence can also be demonstrated through documented evidence of any of the following:
 - Educated for 5 years in an English-speaking country; or
 - Within two years of their application date, you have successfully completed in Australia a foundation course or a Senior Secondary Certificate of Education or a substantial part of a Certificate IV or higher-level qualification, from the Australian Qualifications Framework.

Note that other English language tests such as PTE and TOEFL can be accepted. You are required to provide your results so that we can confirm they are equivalent to IELTS 5.5.
